- 1 Drawing of above items must be got approved from the LRQA Inspection Services India LLP before starting manufacturing as per the requirement of Regulation and 393 of Indian Boiler Regulations-1950.
- 2 All material should be offered for inspection and necessary tests (wherever necessary) along with material test certificates before starting fabrication of the above items.
- 3 All welding should be carried out only with **IBR / In-House Qualification by Competent Authority** approved welders and their certificates should be shown to attending Competent Person before commencing the work.
- 4 Construction and workmanship of above items should be as per the requirement of Chapter - III & XII of Indian Boiler Regulations-1950.
- 5 Stage wise inspection to be offered during construction as specified in appendix - J & as per Chapter VIII of Indian Boiler Regulations - 1950.
- 6 The structural steel for above items should be as per the requirement of Chapter- II & XII of Indian Boiler Regulations-1950.
- 7 Welding preparation for all the joints shall be offered for inspection before welding wherever necessary and the required percentage of welded joints shall be offered for destructive and nondestructive tests as per the requirement of the code.
- 8 All the work should be carried out strictly in accordance with Indian Boiler Regulation-1950 to the satisfaction of the Competent Person and Inspecting Authority.
- 9 You shall have to carry out manufacturing of the above items as per the instruction issued from time to time either by Competent Person or by Inspecting Authority.
- 10 Welder must be qualified in appropriate material as per requirement of Chapter-I & XIII of Indian Boiler Regulations-1950 before starting the job in same material.
- 11 If there is any change in the Firm's name, Director & technical staff must be informed to this LRQA at the earliest.
- 12 This permission can be withdrawn at any time without giving notice if the workmanship is found unsatisfactory.
- 13 You are hereby instructed to get it renewed before 60 days from the expiry of this certificate.
